VOLUNTARY DISSOLUTION.) DECREE OF DISSOLUTION

The application for voluntary dissolution of Idaho Marketing, Inc., an Idaho corporation, came on regularly for hearing before the Honorable Henry S. Martin, District Judge, Idaho Falls, Bonneville County, Idaho, on the 9th day of June, 1970, with Holden, Holden, Kidwell, Hahn & Crapo appearing for and on behalf of the above named company, and no objections to said application for voluntary dissolution having been filed, and the Court having considered all of the documents and evidence in the file, and being fully advised in the premises, now, therefore the Court finds as follows:

I

That on the 29th day of April, 1970, Idaho Marketing, Inc., pursuant to Order of this Court, filed with the Clerk of this Court its application for voluntary dissolution as a corporation.

II

That thereafter, in accordance with the Order of this Court entered on April 29, 1970, the Clerk of the Court gave thirty days notice of said application by publication in the Post-Register, a newspaper of general circulation, printed and published in the County of Bonneville, State of Idaho, which thirty days publication was completed May 31, 1970.

III

That no objections to said application for voluntary dissolution have at any time been filed in this matter.

IV

That all of the allegations and statements in the Application for Voluntary Dissolution on file in this matter are true, and that it appears to the Court and the Court finds that at a meeting of the stockholders of the corporation called for that purpose, dissolution of said corporation was resolved by unanimous vote of all corporate stockholders present; that all claims and demands against the corporation have been satisfied and discharged; that the location of the principal office of the corporation is in Idaho Falls, Bonneville County, Idaho; that the names of the officers and directors are as set forth in the verified Petition on file herein.

NOW, THEREFORE, IT IS ORDERED, ADJUDGED AND DECREED, that the said Idaho Marketing, Inc., an Idaho corporation, be, and the same hereby is declared to be dissolved.

IT IS FURTHER ORDERED, that Wilford Bingham, Wayne C. Hammond, and Gene E. Taylor are entitled to be, and by the Court hereby are, appointed trustees for the stockholders of said corporation with full power and direction to settle all of the affairs of the corporation, and to distribute and convey any and all of the property of said corporation, if any may be found, to the stockholders of said corporation, in proportion to the number of shares owned and held by the stockholders when such distribution and conveyance shall be made.
