ARTICLES OF INCORPORATION

I, the undersigned, being a natural person of full age, and a citizen of the United States, have this day executed these Articles for the purpose of forming a private corporation under the laws of the State of Idaho and to the end hereby adopt these Articles of Incorporation as follows:

ARTICLE ONE

NAME OF CORPORATION

The name of the Corporation is S J International, Inc.

ARTICLE TWO

PURPOSE OF INCORPORATION

The nature of the business and the objects and purposes to be transacted, promoted, and carried on by the Corporation are to do any and all of the things herein mentioned as fully and to the same extent a natural person might or could do in any part of the world as follows:

To transact any or all lawful business for which corporations may be incorporated under the "Idaho Business Corporation Act" as it is presently constituted or may hereinafter be amended.

ARTICLE THREE

DURATION

The duration of the Corporation is perpetual.

ARTICLE FOUR

REGISTERED OFFICE AND REGISTERED AGENT

The address of the Corporation's initial registered office is 11203 West Hummingbird Drive, Boise, Idaho 83709 and the name of its initial registered agent at such address is Roger L. Freudenberg.

ARTICLE FIVE

STOCK

The aggregate number of shares which the Corporation shall have authority to issue is 1,000. Such shares shall consist of one (1) class only and the par value of each of such shares is \$1.00.

ARTICLE SIX

BOARD OF DIRECTORS

ARTICLE EIGHT

LIMITATION ON DIRECTORS' LIABILITY

A director of the Corporation shall not be personally liable to the Corporation or its stockholders for monetary damages for breach of fiduciary duty as a director, except for liability (i) for any breach of the director's duty of loyalty to the Corporation or its stockholders, (ii) for acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law, (iii) under Section 3-1-48 of the Idaho Business Corporation Act or (iv) for any transaction from which the director derived any improper personal benefit. Any repeal or modification of this paragraph 8 by the stockholders of the Corporation shall be perspective only and shall not adversely affect any right or protection of a director of the Corporation existing at the time of such repeal or modification.
