

ARTICLES OF INCORPORATION OF THE
ADA COUNTY FARMERS' IRRIGATION COMPANY.

Know all men by these presents, that we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a Corporation, under the laws of the State of Idaho.

And we hereby certify:

First. That the name of said Corporation is The Ada County Farmers' Irrigation Company.

Second. That the object, business and pursuit of said Corporation is and shall continue to be to acquire, construct, own, hold, operate and maintain water, water rights, canals, ditches, dams, weirs, flumes, reservoirs, aqueducts and systems for the use, operation and distribution of water for irrigation, mining, power, domestic and other purposes.

Third. That the place where its principal business is to be transacted is the town of Boise City, Ada County, State of Idaho.

Fourth. That the term for which it is to exist is fifty years from and after the date of its incorporation.

Fifth. That the number of its directors shall be seven, and that the names and residences of those who are appointed for the first year are:

Sixth. That the amount of the capital stock of this Corporation shall be two hundred and fifty thousand dollars (\$250,000), divided into twenty-five thousand shares (25,000) of the par value of ten dollars each.
