The Undersigned, acting as incorporator of a corporation under the Idaho Non-profit Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be Firstborn Ministries, Inc.
The corporation is a non-profit corporation.

ARTICLE II

The period of the corporation's duration is perpetual.

ARTICLE III

The corporation is organized for the pupose of operating a church or churches for the spreading of the Gospel of Jesus Christ, the private and public worshipping of God, the establishment of believers in the Christian life and salvation through the shed blood of Jesus Christ, nurture and care of it's members and others, the studying of God's Word and providing a Christian education.
