ARTICLES OF INCORPORATION

The undersigned incorporators desiring to form a corporation pursuant to the provisions of the Idaho Business Corporation Act, adopt the following Articles of Incorporation.

ARTICLE ONE: The name of the corporation is NEW HORIZONS, LIMITED.

ARTICLE TWO: The period of duration of the corporation is perpetual.

ARTICLE THREE: The purposes of the corporation are: (1) to own and operate a store for the retail sales and services of motorcycles, boats, and other sport vehicles; and (2) to engage in any and all lawful business for which a corporation may be organized under the Idaho Business Corporation Act.

ARTICLE FOUR: The corporation shall issue only one class of stock. The total number of authorized shares that the corporation shall issue is ten thousand (10,000), which shall be without par value.

ARTICLE FIVE: Shareholder preemptive rights shall not be denied.

ARTICLE SIX: There are no provisions in these articles for regulation of the internal affairs of the corporation.
