I, **JAS. W. NOBLE**, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the original of the articles of incorporation of

**DELTA THETA HOUSE CORPORATION OF ALPHA GAMMA DELTA, INC., OF MOSCOW**

was filed in the office of the Secretary of State on the **twenty-fifth** day of **May** A. D. One Thousand Nine Hundred **Fifty-nine** and is duly recorded on Film No. **107** of Record of Domestic Corporations of the State of Idaho, and that the said articles contain the statement of facts required by Sections 30-103, 30-1101 and 30-1102, Idaho Code.

AND I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name stated in the articles, and for **perpetual existence** from the date hereof, with its registered office in this State located at **Moscow** in the County of **Latah** and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 30, Idaho Code.

1                   ARTICLES OF INCORPORATION OF DELTA THETA  
2                   HOUSE CHAPTER OF ALPHA GAMMA DELTA, INC.  
3                   OF MOSCOW.

4 KNOW ALL MEN BY THESE PRESENTS:

5                   That we, the undersigned, have this day voluntarily associated  
6 ourselves together for the purpose of forming a corporation under the  
7 provisions of Chapter 11, Title 30, of the 1947 Idaho Code for the State of  
8 Idaho, and acts amendatory and supplemental thereto, and we do hereby  
9 certify and declare as follows:

11                                   Article I.

12                   The name of this corporation shall be DELTA THETA HOUSE  
13 CORPORATION OF ALPHA GAMMA DELTA, INC., OF MOSCOW. Its  
14 office and place of business and post office address shall be 1038 Blake,  
15 Moscow, Idaho.

17                                   Article II.

18                   The purposes for which this corporation is formed are:

19                   (1) To purchase and own land, both improved and unimproved;  
20 to purchase or build, operate and maintain residence or lodge rooms for  
21 the use of members of Delta Theta Chapter of Alpha Gamma Delta and its  
22 pledges and guests;

24                   (2) To mortgage, convey in trust, grant, convey, quit-claim  
25 real property and personal property as the same may become necessary,  
26 advisable or desirable;

27                   (3) To acquire and receive by gift, will, devise, deed, lease,  
28 or in any other legal manner, any real or personal property given for the  
29 use and benefit of this corporation in carrying out its objects and purposes.

31                   (4) To borrow money and to execute notes, mortgages, deeds  
32 of trust, and to execute, deliver, and use in its ordinary business

1 transactions all forms of paper commonly used in trade and exchange;

2 (5) To enter into all manner of contracts, including the purchase  
3 and sale of real property and all other manner of contracts which become  
4 necessary or expedient in carrying out the purposes of this corporation,  
5 among which shall be included contracts of guaranty and suretyship;

6 (6) To acquire by purchase, gift, or in any other legal manner,  
7 and to own, hold, sell, assign, transfer, and hypothecate shares of capital  
8 stock and bonds and other debentures of other corporations and of govern-  
9 ments and political subdivisions thereof, and to vote the shares of capital  
10 stock of corporations while the same are held by this corporation all in the  
11 same manner as a natural person may do;

12 (7) To make reasonable and sufficient charges to members of  
13 Alpha Gamma Delta and its pledges to cover costs of carrying out the above  
14 purposes;

15 (8) To perform every other lawful act in the furtherance of the  
16 objects of this corporation as a natural person would have the right to do.

17 (9) To appoint such officers, employees and agents as the  
18 business of the corporation may require, and to allow them compensation.

19 (10) To enter into contracts or obligations of any type or kind  
20 that are essential, necessary or proper for the transaction of its ordinary  
21 affairs or for the purposes of the corporation.

### 23 Article III.

24 The place where its principal business is to be transacted shall  
25 be Moscow, Latah County, State of Idaho.

### 26 Article IV.

27 The time for which this corporation is to exist is not limited, but  
28 it shall exist perpetually unless dissolved according to law.

1 with the by-laws of the corporation to be adopted. Provided, however, that  
2 the by-laws may provide for automatic expiration of and/or re-election to

4 Article VIII.

5 The property, business and affairs of the corporation shall be  
6 under the control and management of the directors.

7 Article IX.

8 The Board of Directors shall have power to make, amend, and  
9 repeal the by-laws of this corporation by an affirmative vote of two-thirds  
10 of all the directors present at any regular or special meeting of the board.  
11 By-laws made by the directors pursuant to this article may be altered or  
12 repealed by vote of two-thirds of the membership.

13 Article X.

14 All of the undersigned incorporators are residents of the State  
15 of Idaho.

16 Article XI.

17 That a meeting of the members of the association known as the  
18 DELTA THETA HOUSE CHAPTER OF ALPHA GAMMA DELTA, was duly  
19 and regularly called to convene in the Chapter House at 1038 Blake, Moscow,  
20 Idaho, at the hour of 8:00 o'clock P. M., on the 30th day of March,  
21 1959, and that a majority of the members of said association were present.

22 That a notice of said meeting at which said directors were  
23 elected was published in the Daily Idahonian, a newspaper printed and pub-  
24 lished in Moscow, Latah County, Idaho, and having a general circulation  
25 therein, said notice having been published in the issues of March 14,  
26 March 21 and March 28, 1959, and that a copy of  
27 said notice was posted in a conspicuous place on the building where such  
28 election was held, for the same length of time.
