The undersigned, acting as incorporatory a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

1.

The name of the corporation is Neimar Inc.

The purpose for which the corporation is formed is to engage in all lawful purposes for which a corporation may be incorporated under the Idaho Business Corporation Act, Title 30. i.e. which shall include, but not be limited to: research, development, and marketing.

The period of existence of this corporation shall be perpetual.

IV.

The location and post office address of the registered office of the corporation in the State of Idaho is 29525 Wallridge Road, Cataldo, Idaho, 83810. The name of the registered agent at that address is Mary E. White.

The total authorized number of par value shares of stock is 1,000,000. The par value of each authorized share shall be 10 cents, and the aggregate par value of the total authorized number of par value shares is therefore \$100,000.00. There are no shares without par value.

The Board of Directors shall have authority to issue bonds, debentures, or other obligations of the corporation from time-to-time for any of the objects or purposes of the corporation and secure them my mortgage, deed of trust, or pledge of any or all of real and personal property, rights, privileges, and franchises of the corporation wheresoever situated, acquired, and to be acquired, and to sell or otherwise dispose of any or all of such obligations in any manner and on such terms as the Board of Directors may deem proper.

The corporation shall have the power to purchase, receive, redeem, or otherwise acquire, own, hold, sell, mortgage, pledge, or otherwise acquire or dispose of and otherwise use and deal in and with its own shares of stock.

VIII.

The corporation shall indemnify any and all person who may serve or who have served at any time as directors or officers, or who at the request of the Board of Directors of the corporation may serve or at any time have served as directors or officers of another corporation in which the corporation at such time owned or may own shares of stock or of which it was or may be creditor, and their respective heirs, administrators, successors, and assigns, against any and all expenses, including amounts paid upon judgments, counsel fees, and amount paid in settlement (before or after suit is commenced), actually and necessarily incurred by such persons in connection with the defense or settlement of any claim, action, suit, or proceeding in which they, or any of them, are made parties, or a party, or which may be asserted against them or any of them, by reason of being or having been directors or officers or a director or officer of corporation, or such other corporation, except in relation to matters as to which any such director or officer or former director or officer or person shall be adjudged in any action, suit, or proceeding to be liable for his own negligence or misconduct in the performance of his duty, such indemnification shall be in addition to any other rights to which those indemnified may be entitled under any law, bylaw, agreement, vote of stockholders, or otherwise.
