ARTICLE I.

The duration of the corporation shall be perpetual.

To borrow money and to make and issue notes, bonds, debentures, obligations and evidences of indebtedness of all kinds, whether secure by mortgage, pledge or otherwise without limit as to amount except as may be prohibited by statute and to secure the same by mortgage, pledge or otherwise and generally to make and perform agreements and contracts of every kind and description.

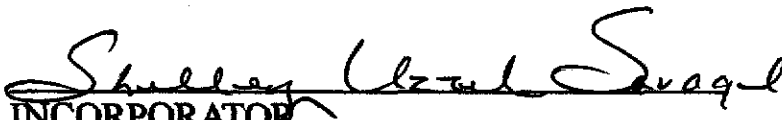
ARTICLE IX.
