KNOW ALL MEN BY THESE PRESENTS: That I, Robert P. Brown, undersigned, Robert P. Brown, a natural person of full age and a resident and citizen of the State of Idaho, as Incorporator, do hereby execute, acknowledge and adopt these Articles of Incorporation, in duplicate, certifying as follows:

**Article I.**

**Name**

The name of the corporation is and shall be:

MATTHEW A. STEIN, JR., M.D., P.A.

**Article II.**

**Purposes**

The purposes for which said corporation is formed and organized are:

(a) To engage in and conduct the business of rendering professional services as physicians and surgeons, including any other or similar services to the public usually and customarily rendered by physicians and surgeons, authorized and licensed as such by the laws of the State of Idaho.

(b) To invest funds for said corporation in any type of investment, including, but not limited to, real estate, mortgages, stocks and bonds.

(c) To acquire, hold, lease, manage and maintain real and personal property necessary for the rendering of authorized professional services of such corporation.

### **Article III.**

#### **Duration**

Said corporation shall have perpetual existence.

### **Article IV.**

#### **Location of Registered Office and Agent**

The address of the initial registered office of the corporation is 321 13th Street, Lewiston, ID 83501, and the name of the registered agent at such address is Robert P. Brown.

### **Article V.**

#### **Capital Stock**

The amount of the capital stock which the corporation is authorized to issue shall be fifty thousand (50,000) shares.

### **Directors**

No shareholder of said corporation may sell, assign or transfer his shares in said corporation except to another individual who is eligible to be a shareholder of said corporation, in accordance with these Articles of Incorporation, and any such sale, assignment or transfer may be made only after the same shall have been approved with the Bylaws and regulations of said corporation appertaining to sale, assignment or transfer
