

ARTICLES OF INCORPORATION

of

STENCIL ART, INC.

The following Articles of Incorporation are hereby adopted pursuant to the Idaho Business Corporation Act:

1. Name.

The name of the corporation is:

STENCIL ART, INC.

2. Duration.

The corporation shall have perpetual duration.

3. Purposes.

The corporation is formed for the purposes of carrying on and conducting the business of designing, manufacturing, promoting, writing, printing, and selling of all kinds of books, pamphlets, periodicals, posters, circulars, cards, patterns, designs, stencils, paints, brushes, and prints, and such other and further items or objects similar thereto, or as may be necessary and incidental to the carrying on of such business, including the buying, leasing, owning, and operating the necessary property, tools, equipment and businesses used in connection therewith, and for the carrying on of any or all other lawful businesses for which corporations may be incorporated under the Idaho Business Corporation Act.

4. Authorized Shares.

The corporation shall be authorized to issue 50,000 shares, all of one class, for a par value of \$1.00 per share.
