

**ARTICLES OF INCORPORATION**  
of

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho; and we hereby certify:

1.

That the name of said corporation is "First Church of Christ, Scientist, of Moscow, Idaho".

2.

That the purpose for which said corporation is formed is the carrying on and conducting public worship and the benevolent purposes connected therewith, according to the tenets of the religious denomination known as "Christian Scientists"; also, <sup>to</sup> acquire, hold and use all such real estate and other property as may be reasonably necessary for the purpose of carrying into effect the objects hereinbefore mentioned.

3.

That the place where the principal business of said corporation is to be transacted is Moscow, Latah County, Idaho.

4.

That the term for which it is to exist is fifty years from and after the date of its incorporation.

That the directors for the control and management of the business of said corporation are five in number, and that the names and residences of those who have been elected for the first year are as follows, to wit:
