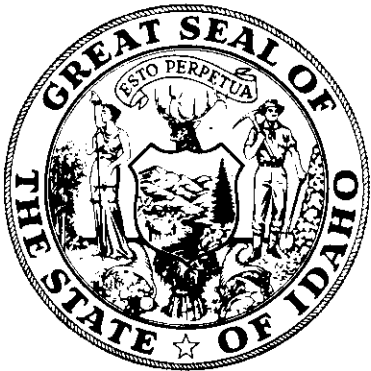

CERTIFICATE OF INCORPORATION

of

WE THE UNDERSIGNED, desiring to form a corporation, for profit, under the general corporation laws of the State of Idaho, do here make, subscribe, acknowledge, and file this certificate for that purpose as follows:

FIRST: The name of the proposed corporation is: SKIPPY'S HAIR STYLING, INC.

SECOND: The principal office of the corporation is to be located in the city of Wallace, Idaho 83873, county of Shoshone.

THIRD: Jean Ann Striker, with offices located at 415 Seventh Streets, Wallace, Idaho 83873, is the registered agent on whom process may be served.

FOURTH: The purposes for which the corporation is to be formed are:

1. Provide barbering and cosmetology services to the general public and offer other services and supplies that are supplied by such shops;

2. To borrow money, contract debts, and to exercise any and all powers as a natural person could lawfully make, perform or exercise which may be necessary, convenient for the accomplishment of any of its objects or purposes providing the same be not inconsistent with the laws of the State of Idaho and to that end enumeration of such powers shall not be deemed inclusive.

FIFTH: The term of existence of this corporation shall be perpetual.

SIXTH: The total authorized capital stock of the corporation is TEN THOUSAND DOLLARS (\$10,000.00) divided in to TEN THOUSAND SHARES (10,000) of the par value of ONE DOLLAR (\$1.00) each.
