

WESTERN FABRICATING, INC.


Pursuant to Idaho Code § 30-1-61, and the authority of resolution of sole director of the corporation dated September 24, 1985, the undersigned sole incorporator and director of the corporation renders these Articles of Amendment and represents as follows:

- (a) Name of the Corporation: Western Fabricating, Inc.
- (b) Amendment adopted: That Article Fourth of the Articles of Incorporation of Western Fabricating, Inc. be amended to read:

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is five hundred thousand (500,000) shares of no par value common stock.

- (c) Date of adoption of amendment by director:  
September 24, 1985.
- (d) Shares outstanding: No shares are outstanding and entitled to vote on the amendment, individually or as a class.
- (e) Share voting: No shares of the stock of the corporation have yet been issued.
- (f) Exchange, Reclassification or Cancellation of Issued Shares: No shares have yet been issued.
- (g) Effect on stated capital: Such amendment does not effect a change in the stated capital of the corporation.


