ARTICLES OF INCORPORATION

OF

CONFIVE, INC.

THE UNDERSIGNED, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE ONE

The name of the Corporation is CONFIVE, INC.

ARTICLE TWO

The duration of the Corporation shall be perpetual, unless dissolved by process of law.

ARTICLE THREE

The purpose or purposes for which the Corporation is organized are:

Transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE FOUR

The aggregate number of shares which the Corporation shall have authority to issue is 5,000 shares of the par value of \$1.00 each; the aggregate par value of the total authorized number of par value shares is \$5,000.00. The amount of such stock may be issued in such amounts and proportions as from time to time shall be determined by the Board of Directors, subject, however, to restrictions as may be now or thereafter created or imposed by law.

ARTICLE FIVE

The address of the initial registered office of the Corporation is 97 South Oak Street, Blackfoot, Idaho 83221, and the name of its initial registered agent at such address is Thomas B. Smith.

ARTICLE SIX

The number of Directors constituting the initial Board of Directors of the Corporation is two, and the names and addresses of the persons who are to serve as Directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:






