Name of Corporation

The name of the corporation is Boise Christian Church, INC.

Period of Duration

The period of duration is perpetual unless sooner dissolved by law.

In the event of dissolution, the residual assets of the corporation shall be turned over to one or more organizations which themselves are exempt as organizations described in sections 510 (c) (3) and 170 (c) (2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State, or local government for exclusive public purpose.

Purpose of Corporation

The purposes for which this corporation is organized are:

- 1. To promote, encourage, or foster, by all proper and legitimate means, the dissemination of religious and moral teaching and instruction for the support of public worship.
- 2. To purchase, sell and/or lease personalty and realty in connection with the establishment and continuation of the operation of a church.
- 3. To exercise all such power and authority as may be necessary to carry out the purposes and objectives above mentioned.

The purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue law.

Notwithstanding any other provision of these articles, this organization shall not carry on any other activities not permitted to be carried on by an organization exempt from the Federal income tax under section 501 (c) (3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue law.
