

ARTICLES OF INCORPORATION
OF
THE STANDARD PUBLISHING COMPANY, LIMITED.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, all of whom are bona fide residents of the State of Idaho, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho.

AND WE HEREBY CERTIFY:

First. That the name of the Corporation shall be THE STANDARD PUBLISHING COMPANY, LIMITED.

Second. That the purpose for which it is formed shall be to engage in and carry on a general printing and publishing business, and to publish, print, issue and sell newspapers, to collect and sell news, to do job printing and printing of every kind, engraving and lithographing; and to acquire and own a printing plant or plants, real estate, mining claims and interests therein, and mining and other stocks, and other property; and to sell and dispose of the same, and to mortgage or pledge the same; and to make and execute negotiable instruments, and to borrow money for the purpose of carrying on the business of the corporation; and to do all of said things in the State of Idaho or elsewhere.

Third. That the place where its principal business is to be transacted is the City of Grangeville, County of Idaho, State of Idaho.

Fourth. That the term for which it is to exist is fifty years from and after its incorporation.

Fifth. That the number of its Directors shall be five; and that the names and addresses of those chosen for the first year are: C.J.Lisle, residing at Grangeville, Idaho.

L.G.Bradley, residing at Grangeville, Idaho.

E.W.Oliver, residing at Grangeville, Idaho.

W.A.Hall, residing at Grangeville, Idaho.

Burt L.Crosby, residing at Grangeville, Idaho.

Sixth. That the amount of the capital stock of the said corporation is TEN THOUSAND DOLLARS (\$10,000); and the number of shares into which it is divided is ten thousand (10,000) of the par value of One Dollar (\$1.00) each.
