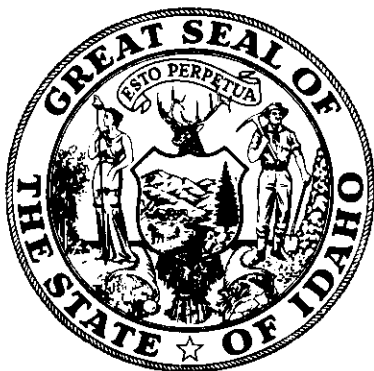

ARTICLES OF INCORPORATION

OF

HOLLEN J. HILLER, D.D.S., PROFESSIONAL ASSOCIATION

The undersigned, acting as the incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation.

FIRST: The name of the corporation is:

HOLLEN J. HILLER, D.D.S., PROFESSIONAL ASSOCIATION

SECOND: The period of its duration is perpetual.

THIRD: The purpose for which the corporation is organized is to provide services in the field of dentistry and related fields as provided by the laws of the State of Idaho.

FOURTH: The aggregate number of shares which the corporation has authority to issue is fifty (50) shares of common stock, all of one class, of the par value of One and No/100 (\$1.00) Dollar each, and an aggregate par value of Fifty and No/100 (\$50.00) Dollars.

FIFTH: The address of the initial registered office of the corporation is 749 Oxford Avenue, Idaho Falls, Idaho 83401, and the name of its initial registered agent at such address is Hollen J. Hiller.


