
merging with and

ARTICLES OF MERGER
OF

DIXIE SERVICE COMPANY AND BIGGERS CONSTRUCTION COMPANY, INC.

Pursuant to Section 30-1-74 Idaho Code, Dixie Service Company and Biggers Construction Company, Inc. hereby adopt these Articles of Merger.

1. The Plan of Merger is as follows:

a. Dixie Service Company shall merge into Biggers Construction Company, Inc. Biggers Construction Company, Inc. shall be the surviving company.

b. Homer L. Biggers, the sole shareholder of Dixie Service Company, will transfer all of the issued and outstanding shares of stock of Dixie Service Company (there are presently issued and outstanding thirty (30) shares of Dixie Service Company) to Biggers Construction Company, Inc. in return for which Biggers Construction Company, Inc. shall issue thirty (30) shares of stock to Homer L. Biggers. All of the assets of Dixie Service Company shall be transferred to Biggers Construction Company, Inc. and Biggers Construction Company, Inc. shall assume all of the liabilities of Dixie Service Company. All of the issued and outstanding shares of Dixie Service Company shall then be cancelled. Dixie Service Company will then cease to exist.

c. No changes will be made in the Articles of Incorporation of Biggers Construction Company, Inc. because of the merger of Dixie Service Company into Biggers Construction Company, Inc.

2. The number of issued and outstanding shares of stock of Biggers Construction Company, Inc. is eighty-nine (89). The number of issued and outstanding shares of stock

of Dixie Service Company is thirty (30).

3. Thirty (30) of the shares of Dixie Service Company voted for the Plan of Merger and zero (0) number of shares of Dixie Service Company voted against the Plan of Merger. Eighty-nine (89) of the shares of Biggers Construction Company, Inc. voted for the Plan of Merger and zero (0) number of shares of Biggers Construction Company, Inc. voted against the Plan of Merger.


