RESOLVED, that Article I be amended to read as follows:

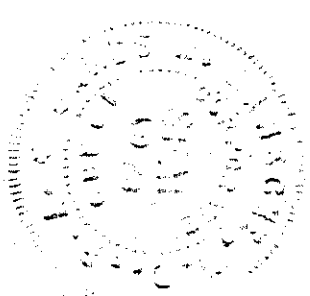
