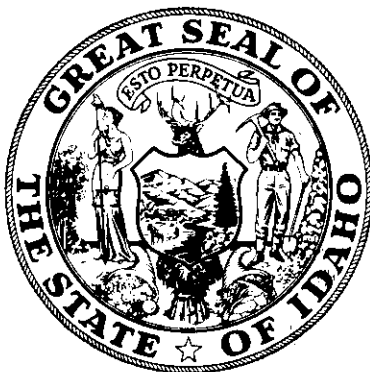

ARTICLES OF INCORPORATION
OF THE

Trinity Baptist Church of Priest River, Idaho.

We, the undersigned, desiring to become incorporated under the provisions of the State of Idaho, do hereby make, execute and adopt the following articles of association, to-wit:

First: The name assumed by this Corporation and by which it shall be known in law, the "Trinity Baptist Church Inc. of Priest River, Idaho.")

Second: (The Trinity Baptist Church Inc. of Priest River, Idaho) shall be a non-profit organization.

Third: The location of said Church shall be in the City of Priest River, County of Bonner and State of Idaho. Post office address P.O. Box 1268 Priest River, Idaho 83856.

Fourth: The time for which this corporation shall be created shall be perpetual.

Fifth: The members of said Church shall worship and labor together according to the usages of regular, fundamental Baptist Churches in the United States of America as authorized and declared in the New Testament and set forth in what is commonly known as the New Hampshire Declaration of Faith with the pre-millennial revision.

Sixth: This Church shall promote the preaching of our Lord and Saviour Jesus Christ; the furtherance of Home and Foreign Missions for the same purpose; the distribution of Gospel tracts and other Christian literature, and the teaching of the subject to any ecclesiastical control whatsoever from any convention conference, or association of any kind: but shall be free to associate with or disassociate from, any associated groups of Baptists of like faith and practice for the purpose of Fellowship and Missionary endeavor. The government of this church is vested in its membership. Voting privileges shall be extended to members in good and regular standing 16 years of age and over.

DISSOLUTION

Seventh: No part of the net earnings of this corporation shall ever inure to the benefit of any donor, member, director, or officer of the corporation or any private individual and no donor, member, director officer of the corporation or any private individual shall be entitled to share in the distribution of any of the corporate assets. Upon dissolution, any assets of the corporation

dividual shall be entitled to share in the distribution of any of the corporate assets. Upon dissolution, any assets of the corporation must be distributed to one or more organizations recognized by the Internal Revenue Service as one organized exclusively for religious, charitable, scientific, literary or educational purposes, of like faith and practice of this corporation.
