**ARTICLES OF INCORPORATION

I, the undersigned natural person of the age of 18 years or more, acting as incorporator under Title 30, Chapter 1, Idaho Code, hereby submit the following Articles of Incorporation.

ARTICLE I: Name of Corporation

The name of the corporation shall be as follows: Mark Bekker, Inc.

ARTICLE II: Duration

The duration of this corporation is perpetual, provided, however, that the corporation may be dissolved at any time according to law.

ARTICLE III: Corporate Purposes

The purpose of this corporation is to engage in sales, marketing, recruiting and training related to pest control products and services.

In addition, the corporation reserves the right to conduct any and all lawful business for which corporations may be organized under Idaho law.

ARTICLE IV: Powers

The corporation, subject to any limitations imposed by these Articles of Incorporation or Idaho law, shall have and exercise the same powers as an individual to do all things necessary or convenient to carry out its permitted business purposes, activities, and affairs.

ARTICLE V: Shares of Stock

The corporation shall have authority to issue ten thousand (10,000) shares of common stock.

ARTICLE VI: Stock Restrictions

All shares of stock in the company are assignable and any stockholder may sell, assign or transfer his or her shares and certificate or certificates of stock at pleasure, provided that no member can sell, assign, give or transfer to another without first offering his or her shares for sale or gift to the other stockholders and giving them a reasonable



Further, no such transfer, gift or assignment shall be valid unless and until it shall have been entered upon the books of the company and the older certificate or certificates shall have been surrendered for cancellation to the secretary and a new certificate or certificates issued in lieu of the same.
