KNOW ALL MEN BY THESE PRESENTS That we, the undersigned, hereby associate ourselves together for the intention of forming a non-profit cooperative association, under the provisions of Chapter 10, Title 30, Idaho Code, and do hereby execute, subscribe and acknowledged in triplicate, the following ARTICLES OF INCORPORATION:

ARTICLE I

The name by which this corporation shall be known is the COMMUNITY ACTION AGENCY, INC.

ARTICLE II

THE objects and purposes for which this corporation is formed are to provide guidance and facilities which are conducive to and will bring about an orderly development of a program to meet the economic and social needs of the area in which the said Community Action Agency, Inc., will function and be authorized to do busines enable said corporation to carry out these objects and purposes, it shall have the power to purchase, lease or otherwise acquire real and personal property; to receive gifts and hold the same in trust; to enter into contracts or obligations of any type or kind necessary or proper for the accomplishment of the purposes for which the said corporation is organized, or which shall at any time appear conducive or expedient for the protection or benefit of said corporation or in the furtherance of its activitive, or any of them.

ARTICLE III

The duration of this corporation shall be perpetual.

ARTICLE IV
