

Designation of Agent, and Acceptance of the Provisions of the Constitution of the State of Idaho.

KNOW ALL MEN BY THESE PRESENTS:

That SPOKANE VALLEY LAND AND WATER COMPANY,
a Corporation organized and existing under the laws of the State of Washington,
having filed in the office of the Secretary of State of the State of Idaho a duly authenticated copy
of its Articles of Incorporation, does hereby, in pursuance of the laws of the State of Idaho, make
this certificate, and does hereby designate Kootenai County, in the State of Idaho, as
the County in which the principal place of business of said Corporation in said State of Idaho is
and shall be conducted, and does hereby designate GEORGE STEELE,
residing at Coeur d'Alene City
in said Kootenai County, as the authorized Agent of said Corporation in said State
of Idaho, upon whom process issued by authority of, or under any law of the State of Idaho, may
be served, as provided by the Constitution and laws of said State of Idaho.

And the said SPOKANE VALLEY LAND AND WATER COMPANY,
desiring and intending to conform in all respects to the Constitution and laws of said State, and to
avail itself of the rights, privileges and immunities guaranteed by said Constitution and laws, does
hereby accept the provisions of the Constitution of the State of Idaho for all the intents and pur-
poses contemplated by the provisions thereof, relating to such acceptance by other than municipal
corporations. (Article XI, Section 7, Constitution of Idaho.)
