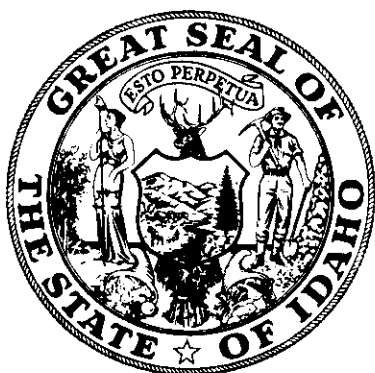

ARTICLES OF INCORPORATION  
OF

SYRINGA LAND & TIMBER COMPANY

I, the undersigned, being an adult citizen of the United States of America, for the purpose of forming a corporation pursuant to Chapter 1 of Title 30, Idaho Code, do hereby adopt and certify the following Articles of Incorporation, towit:

ARTICLE I

The name of this Corporation shall be "SYRINGA LAND & TIMBER COMPANY".

ARTICLE II

The term of existence of this corporation shall be perpetual.

ARTICLE III

The purposes for which this corporation is organized are the transactions of any and all lawful businesses for which corporations may be incorporated under this act.

ARTICLE IV

The aggregate number of shares of which the corporation shall have the authority to issue is one hundred thousand (100,000); the shares shall consist of one (1) class only; the par value of each share shall be the sum of One Dollar (\$1.00); the total authorized capital stock of the corporation is the sum of One Hundred Thousand Dollars (\$100,000.00). The stock of this corporation shall be nonassessible.

ARTICLE V

The address of the initial registered office of the corporation is Syringa, Idaho 83539. The name of the initial registered agent of the corporation at the initial registered office of the corporation is Donald A. Denton. The mailing

3 The corporation shall have four (4) directors, ex-  
4 cept in the event that all of the shares of the corporation are  
5 owned beneficially and of record by fewer than four (4) share-  
6 holders, in which event the number of directors may be fewer  
7 than four (4) but not fewer than the number of shareholders.

8 The initial Board of Directors shall consist of
