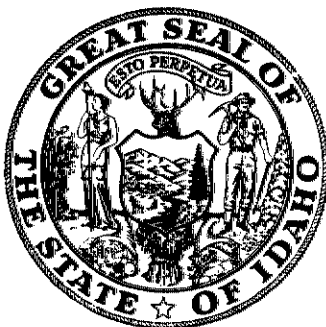

1. Name.



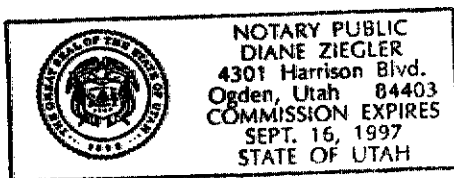


