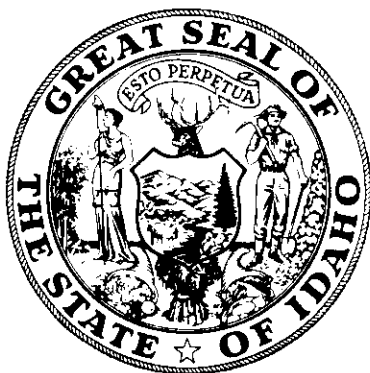

ARTICLES OF INCORPORATION  
OF

ARTICLE I.

The name of the corporation is ENERGY INDUSTRIES WEST, INC.

ARTICLE II.

The period of its duration is perpetual.

ARTICLE III.

Its purpose is principally the manufacturing and development of energy saving products and equipment; conduct engineering and research in connection therewith; to publish literature, Periodicals, books and writings on energy saving and to do all things not prohibited by law in pursuance thereof, and to otherwise transact all business not forbidden by law.




