November, A. D., 1963, and will be duly recorded on microfilm  
of Domestic Corporations, records of the State of Idaho, and  
that the said Articles contain the statement of facts as  
required by law.

6                   KNOW ALL MEN BY THESE PRESENTS:

7                   THAT WE, The undersigned, being the Board of Trustees of  
8                   the Church of God of Middleton, Idaho, duly chosen and elected in  
9                   conformity with the constitution, canons, rights, regulations, and  
10                  discipline of said Church, and in whom is vested the legal title to  
11                  the property of said church, each of said Trustees being a natural  
12                  person of full age and citizens of the United States of America  
13                  and of the State of Idaho, have this day voluntarily associated to-  
14                  gether for the objective of forming a body politic and a corporation  
15                  sole under and pursuant to the provisions of the laws of the State  
16                  of Idaho, and do hereby certify as follows:

17                   ARTICLE I

18                   The name of this Corporation shall be "BOARD OF TRUSTEES OF  
19                   THE CHURCH OF GOD OF MIDDLETON, IDAHO, INC.".

21                   ARTICLE II

22                   The purposes and objects for which the corporation is founded  
23                  are:

24                   (a) For the purpose of acquiring, holding and disposing  
25                  of, by sale or gift, of church property belonging to the  
26                  said Church of God of Middleton, Idaho, and for the  
27                  benefit of said religious group and for public worship.

27                   ARTICLE III

28                   The existence of this Corporation shall be perpetual.

29                   ARTICLE IV

30                   The location of the registered office in this state shall  
31                  be located in Middleton, County of Canyon, State of Idaho, and the

1 Post Office address shall be Middleton, Idaho.

## ARTICLE V

4 That the estimated value of the property belonging to  
5 said Church of God of Middleton, Idaho at the time of the making of  
these Articles of Incorporation, is \$ 7,500.00 .

## ARTICLE VI

8        The sole and only members of this corporation and its  
9        officers and directors shall be the Board of Trustees of The Church  
10      of God of Middleton, Idaho, and their duly qualified successors in  
11      office, and such persons shall have the power to acquire and possess,  
12      by donation, gift, bequest, devise or purchase, and to hold and main-  
13      tain property, real, personal and mixed, and to grant, sell, convey,  
14      give, or otherwise dispose of the same as may be necessary to carry  
15      on or promote the objects of said corporation; and shall have authority  
16      to borrow money and to give written obligations therefor, and to se-  
17      cure payment thereof by mortgage or other lien, upon real and personal  
18      property, and to execute all conveyances and other instruments  
19      necessary in connection with the same.

## ARTICLE VI

21 Amendment of these Articles may be made by and accomplished  
22 only as necessary or hereinafter prescribed by the Laws of the  
23 State of Idaho relating to amendments of the Articles of Incorporation  
24 by corporations.

## ARTICLE VIII

26 The Corporation shall be governed by a Code of By-Laws not  
27 inconsistent with the laws of the State of Idaho and amendments  
28 thereto, which said By-Laws shall be adopted and amended by the  
29 members of the Corporation.

## ARTICLE IX

31 The names and post office addresses of each and all the

1 incorporators, each of whom is a duly chosen, elected or appointed  
2 member of the Board of Trustees of the Church of God of Middleton,  
3 Idaho, are as follows:




