ARTICLES OF AMENDMENT TO

ARTICLES OF INCORPORATION OF

The voting members of Blaine County Farm Bureau, Inc. having been given proper notification, met on this 1st. day of March, 1979 at Picabo, Idaho, for the purpose of amending articles 1 and 10 of the Articles of Incorporation of the Blaine County Farm Bureau, Inc.

Article 1 is amended to read as follows: The name of this corporation shall be Blaine-Camas Bi-County Farm Bureau, Inc.

Article 10 is amended to read as follows: This corporation shall succeed to all the rights of the Camas County Farm Bureau, an unincorporated association. Each Farm Bureau member of Camas County becomes a member of this corporation, which is a member of the Idaho Farm Bureau Federation, which is a member of the American Farm Bureau Federation.
