ARTICLES OF INCORPORATION
OF
HANGFIRE MOUNTAIN MEN, INC.

ARTICLE I

The name of the corporation shall be Hangfire Mountain Men, Inc.

ARTICLE II

The corporation is formed exclusively for purposes for which a corporation may be formed for under the Idaho Code Title 30, Chapter 3, 30-305, Idaho Non Profit Corporation Act. The corporation is not formed for pecuniary profit or financial gain. No part of the assets, income, or the profit of the corporation shall be distributed to, or inure to the benefit of, its members, its directors, or officers except to the extent permitted under the Idaho Code. Corporation shall not operate any listing service for its members, or take specific steps which will serve to facilitate the transaction of specific business by its members or promote the private interest of any member, or engage in any activities which would constitute irregular business of a kind ordinarily carried on for profit.

ARTICLE III

The purpose of Hangfire Mountain Men, Inc., is to promote and foster the use and safety of muzzleloading firearms.

ARTICLE IV

The period of duration is perpetual.

ARTICLE V

The management of the corporation is to be vested in its members pursuant to Title 30, Chapter 3, 30-314(c) Idaho Code.

ARTICLE VI

Any provision, not inconsistent with the law, may be set forth in the By-laws for the regulation of the internal affairs

of this corporation.




