3	residents of the State of Idaho, do hereby voluntarily associate ourselves for	
4	the purpose of forming a non profit corporation under the provisions of	
5	Chapter 3, Title 30, Idaho Code, and amendments thereto. We hereby certify,	
6	adopt and set for the Articles of Incorporation of CARTEL, Inc., as follows:	
7	ARTICLE I.

9	The name of this non profit corporation is CARTEL, Inc.

	directors may establish any number of sub-cl	lasses within each class. Member-		
	ship fees shall be determined by the board of	of directors.		
	C. This corporation is organized	as a non profit corporation for		
	the mutual benefit of its members and consec	quently shall not pay dividends		
	on capital. After all expenses of the corpo	pration have been paid and reason-		
	able reserves as determined by the board of	directors have been set aside, the		
	net earnings of the corporation shall be acc	cumulated for such purposes as the		
	board of directors may determine to be in the	ne best interests of the corporation.

ARTICLE IX.

Provisions for By-Laws

held and the by-laws shall be adopted in accordance with the laws of Idaho,
subject only to theissuance of the Certificate of Incorporation by the
Secretary of State.

ARTICLE X.

Amendment of Articles

These Articles of Incorporation may be amended by the minimum vote required by the laws of the State of Idaho of the members of the corporation at any regular meeting or at a special meeting called for the purpose by a majority of the board of directors after thirty (30) days written notice to all members, which notice shall be in conformance with the statutes of the State of Idaho.
