The undersigned, who are natural persons of full age and citizens and residents of the State of Idaho and the United State of America, for the purpose of forming a corporation under the laws of the State of Idaho, hereby certify and declare:

## ARTICLE I

The name of this corporation shall be Pioneer Plastics, Inc.

### ARTICLES II

The purposes for which it is formed are:

manufacturing and distributing plastics and all lawful purposes for which corporations can be organized.

#### ARTICLE III

The duration of the corporation shall be perpetual.

## ARTICLE IV
