ARTICLES OF INCORPORATION

ARTICLE I - NAME

SECRETARY OF STATE

The name of this corporation shall be: Prepare the Way International, Inc. STATE OF IDAHO

ARTICLE II - PURPOSE

The purpose of this corporation shall be to promote, further and abide by the gospel of Jesus Christ as set forth in the New Testament Scriptures, "Go ye into all the world, and preach the gospel to every creature." Mark 16:15

To accomplish such purpose, the corporation may establish a home and foreign missions outreach, and present the gospel of Jesus Christ through all types of religious activities including programs featuring music and speakers whose subject matter relates to said gospel of Jesus Christ.

The corporation is organized and operated exclusively for charitable, benevolent, and religious purposes. In connection there with, or incidental there to, it shall have the right to purchase or acquire by gifts, bequest or otherwise, either directly or as trustee, and to own, hold in trust, use, sell, convey, mortgage, lease or otherwise dispose of any real estate or chattels as may be necessary or incidental to the performing of any of the above mentioned purposes all on a not for profit basis, as defined by the laws of the State of Idaho, and all other powers permitted by law.

ARTICLE III - TENETS OF FAITH

This corporation accepts the Holy Scriptures as the revealed will of God, the all-sufficient rule for faith and practice; enabling true believers dedicated to serving God to fulfill the Great Commission as set forth in Mark 16:15. We accept the following statement of Fundamental Truths:

We believe the Bible to be the inspired and only infallible and authoritative Word of God. We believe that there is one God, eternally existent in three persons: God the Father, God the Son, God the Holy Spirit. We believe in the deity of our Lord Jesus Christ, in His virgin birth, in His sacrificial death on the cross, in His bodily resurrection, in His ascension to the right hand of the Father, and in His personal future return to this earth in power and glory. We believe that the only means of being cleansed from sin is through repentance and faith in the precious blood of Christ. We believe that regeneration by the Holy Spirit is absolutely essential for personal salvation. We believe in the resurrection of both the saved and lost, the one to everlasting life and the other to everlasting damnation.

ARTICLE IV - DURATION

The duration of said corporation shall be perpetual.

ARTICLE V - BOARD OF DIRECTORS

Section 1. The affairs of this corporation shall be managed by it's Board of Directors, and shall consist of a President, Vice President, Secretary, Treasurer and other Directors as the President may appoint, provided that a majority of the Directors confirm each appointment by the President.

Section 3. The President shall be the executive head of the corporation and shall serve until death, resignation, or replacement. The President shall be removed from the Board of

Directors by a three-fourth majority vote of the existing Board of Directors.

Section 4. The Vice President, Secretary, Treasurer and appointed Directors shall serve for two years after the date of Incorporation. Thereafter they shall be elected by a majority vote

for two year terms.

ARTICLE VI - REGISTERED OFFICE AND AGENT

The location and post office address of its registered office in this state and the name of the registered agent at that address is: Merry M. Hellwege, Registered Agent, 20385 Pear Lane, Caldwell, Idaho

ARTICLE VII - INCORPORATORS

There shall be six incorporators and the name and address of each incorporator shall be and is the same as the initial Board of Directors set forth in Section 2 of Article V of these Articles of Incorporation.

ARTICLE VIII - MEMBERS

This corporation shall have no Members.

ARTICLE IX - GENERAL PROVISIONS

The provisions non inconsistent with law which the incorporators set forth are as follows:

Section 1. No part of the net earnings or the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Two hereof. No substantial part of the activities of the corporation shall be the carrying on or propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) and political campaign on behalf of any candidate for public office. Not withstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (I) by a corporation exempt from Federal Income Tax under Section 501 (c) (3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law), or by (ii) by a corporation contributions to which are deductible under Section (170) (c) (2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

Section 2. Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provisions for the payment of all of the liabilities of the corporation dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational and religious purposes as shall at the time qualify as an exempt organization or organizations under Section 501 (c)(3) of the Internal Revenue Code of 1954 (or the corresponding provisions of any future United States Internal Revenue Law), as the Board of Directors shall determine, and as provided in Ark. Stat. Ann. 1947-64-1924.
