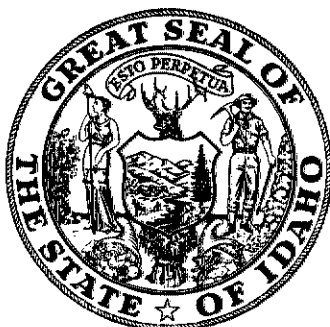

**AMENDED ARTICLES OF INCORPORATION
IDAHO CODE § 30-323**

1. The name of the corporation is Church of Christ, Inc.
2. The corporation is a non-profit corporation.
3. The period of its duration is perpetual.
4. The purpose for which the corporation is formed are as follows:

To provide for the promotion, support, maintenance and establishment at Salmon, County of Lemhi, State of Idaho, of a Church of Christ and to provide a place of public worship for the same; to support the doctrine and be subject to the laws, usages and ministerial appointments of a Church of Christ as from time to established, made and declared by the lawful authority of said church; to establish, maintain and conduct schools for the religious instruction of the young and to further other religious and charitable work, and to that end may adopt and establish by-laws and make all rules and regulations deemed necessary and expedient for the management of its affairs, in accordance with the law and the laws and regulations of a Church of Christ and which are not inconsistent with these Articles; to secure hold, improve, encumber, sell, manage and dispose of property, both real and personal, in fee simple and otherwise. This corporation does not contemplate pecuniary gain or profit.

CORPORATION NON PROFIT AMENDMENT

It is intended that in place of the by-laws of the corporation the corporation shall be operated under the "New Testament".

If Elders are ordained they shall have managing authority for the corporation.

- 4a. This organization is organized exclusively for religious and charitable purposes within the meaning of section 501(c)(3) of the Internal Revenue Code.

Notwithstanding any other provision of these articles, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue law) or (b) by an organization contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue law).

5. The address of its initial registered office is 711 Lombard, Salmon Idaho 83467. The name of its initial registered agent at such address is Phillip Langston.
6. The corporation will not have members.

7. Upon dissolution of the corporation the assets, if any, will go to another Church of Christ. However, if the named recipient is not then in existence or no longer a qualified distributee, or unwilling or unable to accept the distribution, then the assets of this organization shall be distributed to a fund, foundation or organization which is organized and operated exclusively for the purposes specified in section 501(c)(3) of the Internal Revenue Code.
8. The number of directors constituting its initial board of directors, or governing board is two, whose names and addresses are: Phillip Langston, 711 Lombard, Salmon, Idaho and Eddie Patterson, 715 Lombard, Salmon, Idaho.
