In general, the purpose is to carry on any other affairs in connection with the foregoing to exercise the rights or privileges incident to or reasonable, necessary, and convenient to accomplish the purposes of this association and to exercise the general powers of a non-profit corporation.

ARTICLE V.

ARTICLE VIII.

Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on: (a) by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue law) or (b) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue law).

ARTICLE IX.

Upon dissolution of the corporation, the board of directors shall, after paying or making provisions for the payment of all the liabilities of the corporation, dispose of all the assets of the corporation exclusively for the purpose of the corporation in such manner or to such organization or organizations organized exclusively for charitable, educational, religious or scientific purposes, as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1954, or corresponding provisions of any future United States Internal Revenue Law, as the board of directors shall determine. Any such assets not so disposed of shall be disposed of in accordance with the existing laws by the appropriate Court of the County in which the principal officers of the corporation is then located exclusively for such purposes.
