STATEMENT OF CONVERSION OF KOPPEL PROPERTIES LIMITED PARTNERSHIP

- S. Howard Koppel, the sole general partner of Koppel Properties Limited Partnership, an Idaho limited partnership, files this statement of conversion under Title 30, Chapter 18, Part 4, of the Idaho Code. Koppel Properties Limited Partnership is converted into Koppel Properties, LLC, an Idaho limited liability company.
- 1. Statutory Authorization. The conversion is authorized by Idaho Code § 30-18-401(a).
- 2. Name of Converting Entity. Koppel Properties Limited Partnership, an Idaho limited partnership, is the converting entity. Idaho Code § 30-18-405(2)(a).
- 3. Jurisdiction of Organization. Koppel Properties Limited Partnership was organized as a limited partnership under Idaho law on September 5, 1995. Idaho Code § 30-18-405(2)(b).
- 4. Effective Date of Conversion. The conversion is effective upon filing of this statement with the Idaho Secretary of State. Idaho Code § 30-18-405(2)(c).
- 5. Approval of Conversion. S. Howard Koppel, the sole general partner of Koppel Properties Limited Partnership, an Idaho limited partnership, adopted the plan of conversion under Title 30, Chapter 18, Part 4 of the Idaho Code and Article 6 of the Partnership Agreement. Idaho Code § 30-18-405(2)(d).
- 6. Certificate of Limited Partnership. Koppel Properties Limited Partnership attaches a copy of its Certificate of Limited Partnership filed on September 5, 1995. Idaho Code § 30-18-405(2)(e).
- 7. Not a Limited Liability Partnership. Koppel Properties Limited Partnership is not a limited liability partnership. Idaho Code § 30-18-405(2)(f).
