ARTICLES OF INCORPORATION
OF
KETCHUM COMMUNITY PRESBYTERIAN CHURCH, INC.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, citizens of the United States of America and residents of Blaine County, State of Idaho, being all of full age and not in any way disqualified, do by these presents associate ourselves together for the purpose of forming a religious corporation in which pecuniary profit is not a purpose; and we do hereby certify as follows:

ARTICLE I

That a meeting of the worshipers and members of that church and congregation commonly known as KETCHUM COMMUNITY PRESBYTERIAN CHURCH was duly and regularly held on the 23rd day of October, 1966, in the ST. THOMAS EPISCOPAL CHURCH in Ketchum, Blaine County, Idaho, which said church building is the place where said members and congregation meet for public worship. That said meeting was held in compliance with and conformity to the provisions of Chapter 11, Title 30, Idaho Code, for the purpose of electing trustees to take charge of all and singular the property and estate, both real and personal, of said church and to determine whether or not the trustees so elected should proceed to incorporate said church under the provisions of said chapter of the Idaho Code. That due and regular notice of said meeting was given in the manner and form prescribed by law, that proof of such notice is attached hereto and made part hereof, the same being by publication and posting as provided in Section 30-1102, Idaho Code; that at the time and place so designated in said notice to-wit: On the 23rd day of October, 1966, at the hour of 11 o'clock A.M., a majority of the members of such church who were present at such meeting voted at such election and voted unanimously to elect the following named persons as trustees of said

church and as incorporators thereof and as the first Board of Directors of said corporation, to-wit:

WES McDORMAN

That prior to the election of said trustees as aforesaid the said congregation by unanimous vote elected REV. WILLIAM M. KELLEY as chairman of said meeting and WES McDORMAN as Secretary thereof, and said chairman and secretary together received and counted the votes cast at said election.

ARTICLE II

That the name of said corporation shall be KETCHUM COMMUNITY PRESBYTERIAN CHURCH, INC.

ARTICLE III

The registered office of said corporation shall be located at Ketchum, Blaine County, Idaho, and the post office thereof shall also be Ketchum, Idaho.

ARTICLE IV

Said corporation shall have perpetual existence.

ARTICLE V

Said corporation is formed for the purposes hereinafter specified but not for pecuniary profit of its members.

ARTICLE VI

The general purposes of said corporation shall be to operate and maintain the PRESBYTERIAN CHURCH affiliated with the general assembly of the PRESBYTERIAN CHURCH in the United States of America and specifically said corporation shall have the additional following powers:

- A. To give instruction to believers in Christ.
- B. To lead sinners to the Saviour.

- C. To promote the spread of the Gospel of Jesus Christ at home and abroad.
- D. To stimulate the expression of individual and public worship and prayer.
- E. To provide training and inspiration for Christian service.
- F. To encourage active Christian fellowship for believers in Christ.
- G. To purchase, acquire, own, mortgage, encumber, hypothecate, sell, convey and in any manner dispose of all kinds of real and personal property which may be used in the accomplishment of any or all of the foregoing purposes.
- H. To do all other acts and things necessary or expedient in accomplishing any of the foregoing aims, purposes, or powers, without any limitations or restrictions whatever except as what may be determined by the bylaws hereof.

ARTICLE VII

The membership in this corporation shall be determined by the by-laws.

ARTICLE VIII

The promotion, operation and maintenance of the corporation together with the management of church property ~~and real estate~~ shall be vested in a Board of Trustees of the Corporation, consisting of not less than five (5) nor more than fifteen (15) members, who shall be elected and hold office for such term and to exercise such powers as shall be prescribed by the by-laws. The first Board of Trustees shall consist of the members elected as trustees at said meeting held on the 23rd day of October, 1966, they being the following named persons, to-wit:

ARTICLE IX

The Board of Trustees shall make and adopt by-laws and shall ~~provide~~ provide for the method of submitting the same to the members of the

congregation for final approval.

ARTICLE X

There shall be one regular annual meeting of the corporation for the transaction of all business relating to the corporation which may properly come before the members of the congregation, the same to be held at such time and place as may be prescribed in the by-laws and such other special meetings of the corporation as the Board of Trustees shall call from time to time. Notice of all meetings shall be given as prescribed in the by-laws.

ARTICLE XI

These Articles of Incorporation may be amended in the manner and form as authorized by law, and as may be provided by the by-laws.


