## ARTICLES OF INCORPORATION OF ACTUALIZED COMPUTER TRAINING, INC.

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is ACTUALIZED COMPUTER TRAINING, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are for the providing of training activities using computers as mediums. In addition, the Corporation may transact any or all other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 100,000 shares of no-par value stock.

FIFTH: Provisions denying preemptive rights are: None.
