**ARTICLES OF INCORPORATION  
OF  
LAKE CITY PHYSICAL THERAPY, P.A.**

The undersigned, acting as incorporator of a professional service corporation under the Idaho Professional Service Corporation Act, adopts the following Articles of Incorporation for such professional service corporation:

FIRST: The name of the corporation is: Lake City Physical Therapy, P.A.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: To own and operate a business having as its principal purpose the practice of physical therapy, and the transaction of any or all other lawful business for which professional service corporations may be incorporated under the Professional Service Corporation Act.
