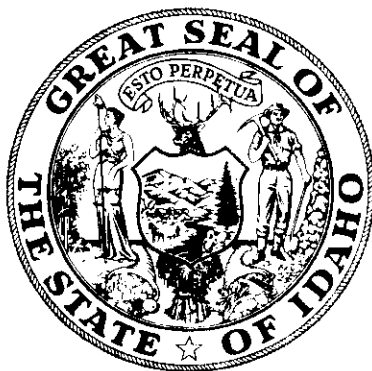

ARTICLES OF INCORPORATION  
OF  
BROOKS, ALLEN AND RUSCITTO, INC.

The undersigned, acting as incorporator of a corporation under the "Idaho Business Corporation Act", adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is BROOKS, ALLEN AND RUSCITTO, INC.

ARTICLE II

The corporation shall have perpetual existence.

ARTICLE III

The purposes for which said corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the "Idaho Business Corporation Act".

ARTICLE IV

The total number of shares of stock which the corporation has authority to issue is 1,000 shares without par value, all of one class.

ARTICLE V

The address of the initial registered office of the corporation shall be 310 Leadville Avenue North, Ketchum, Idaho, and the mailing address of said office shall be P.O. Box 630, Sun Valley, Idaho 83353, and the name of its initial registered agent at such address shall be Peter B. Allen.
