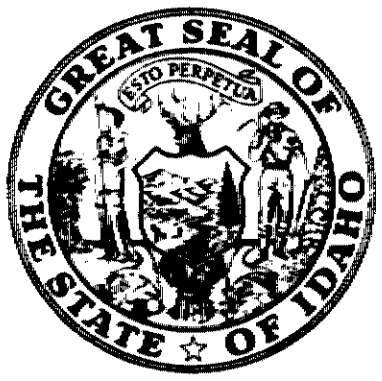

Article 4. Debts. Provisions for all debts, obligations, and liabilities of the corporation have been made so that all of the aforementioned will be discharged or paid.

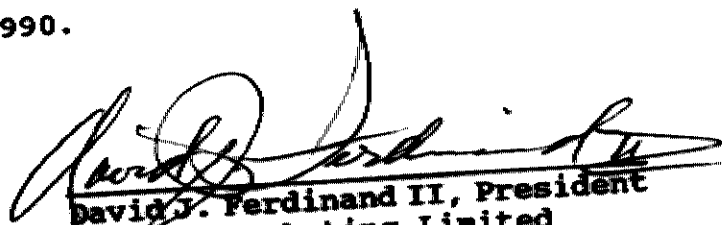
Article 5. Assets of the Corporation. The board of directors, by a majority vote, authorized the sale of whatever assets were necessary to help pay the creditors.

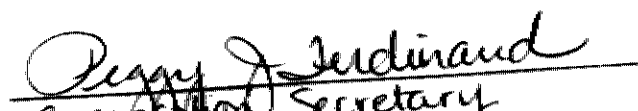
Article 6. Lawsuits or Judgments. As of the date herein there are no pending judgments or lawsuits filed against this corporation.
