ARTICLES OF INCORPORATION  
OF  
SPLITTER CRITTERS, INC.

The undersigned, acting as Incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is SPLITTER CRITTERS, INC.

SECOND: The period of its duration is perpetual, unless dissolved by action of the stockholders, directors or by operation of law.

THIRD: The purpose or purposes for which the corporation is organized are: to engage in business as a wood fuel producer/provider; to provide all services and/or goods or materials associated therewith; to advertise and promote such business; to enter into contracts; and to transact any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The corporation shall have authority to issue 5,000 shares of stock, all of one class, with no par value.

FIFTH: Provisions denying preemptive rights are: NONE.

SIXTH: Provisions for the regulation of the internal affairs of the corporation are: As stated in the By-Laws of the corporation.

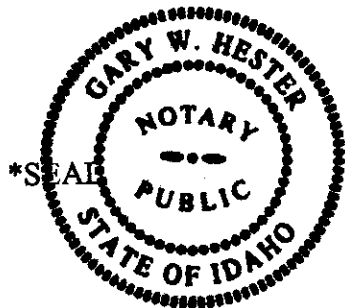
