ARTICLES OF INCORPORATION | 18 AM 15

ALL KITCHENS SUPPLIER ASSOCIATION, INC.

In compliance with the requirements of the law of Idaho relating to nonprofit corporations and acts amendatory and supplemental thereto, including particularly Title 30, Chapter 3, Idaho Code, the undersigned natural person, being of full age and a resident of the United States, in order to form a nonprofit corporation for the purposes hereinafter stated, does hereby as incorporator, adopt the following Articles of Incorporation and certify:

ARTICLE I

NAME

The name of the corporation is ALL KITCHENS SUPPLIER ASSOINC.
CIATION, hereinafter called the "Corporation".

ARTICLE II

NONPROFIT CORPORATION

This Corporation is a nonprofit membership corporation.

ARTICLE III

DURATION

The duration of this Corporation shall be perpetual.

ARTICLE IV

PURPOSES OF THE CORPORATION

1. To promote a better spirit of cooperation and understanding among manufacturers and wholesalers in The Foodservice Industry through increased communication.

- 2. To provide free information service to The Foodservice Industry regarding general market conditions, marketing concepts and general product knowledge.
- 3. To do all other necessary things relative to carrying out the foregoing purposes.

ARTICLE V

POWERS OF THE CORPORATION

The Corporation shall have all the powers provided for in Chapter 3, Title 30, Idaho Code, and as otherwise allowed by law.

ARTICLE VI

MEMBERSHIP

Membership in the Corporation shall be open to all persons and entities in The Foodservice Industry who are associated with All Kitchens, Inc., an Idaho corporation, and who pay the yearly dues otherwise provided for in the By-Laws. Membership includes but is not limited to manufacturers and suppliers in The Foodservice Industry.

The qualification and rights of members, manner of selection and classification of members, if applicable, shall be contained in the By-Laws.

ARTICLE VII

VOTING RIGHTS

Each member of the Corporation shall be entitled to one vote.

ARTICLE VII

CORPORATION ADDRESS

The street address of the initial registered office of the Corporation shall be 209 Main, Boise, Idaho 83702. The name of the initial registered agent shall be Patrick B. Haas at the aforementioned street address.

ARTICLE VIII

BOARD OF DIRECTORS

The initial Board of Directors shall be comprised of six (6) presons who need not be members of the Corporation, and shall serve until the first annual meeting of the members. The initial six directors are as follows:
