ARTICLES OF INCORPORACION

Pursuant to the provisions of the Idaho General Business Corporations Act (Chapter 1, Title 30, Idaho Code), the undersigned corporation adopts these Articles of Amendment to its Articles of Incorporation:

- (1) Prior to the adoption of these amendments, the name of the corporation was PIGGYBACK PRODUCTIONS, INC.
- The following amendment to the Articles of Incorporation was adopted by the shareholders:
- That Article First of the Articles of Incorporation be amended to change the name of the corporation from PIGGYBACK PRODUCTIONS, INC. to LIVING INTERIORS, INC.
