## ARTICLES OF INCORPORATION OF

### EPSTLON CAMMA ZETA OF LAKBDA CHI

#### ALPHA FRATERNITY

We the undersigned, bonafide residents and citizens of the State of Idaho, all of whom are members of Epsilon Gamma Zeta of Lambda Chi Alpha Fraternity, a voluntary social and benevolent association heretofconganized for the sole purpose of promoting social intercourse between its members assisting worthy students at the University of Idaho during their student days both socially and financially, and to provide a home for such of its members as desire to reside in its fraternity house in the city of Moscow, Idaho; in order to more effectually accomplish the objects, aims and purposes of said organization do hereby this day associate ourselves together for the purpose of forming a non-stock, non profit benevolent corporation under and pursuant to the laws of the State of Idaho, and to that end do make, adopt, execute, acknowledge, verify and file the following articles of incorporation.

#### FIRST

The name of said Corporation shall be Epsilon Gamma Zeta of Lambda Chi Alpha Fraternity.

#### SECOND

The objects and purposes of this Corporation are exclusively benevolent and social and in order to enable said organization to carry out its benevolent and social aims, objects and purposes, it shall have power:

- 1. To acquire by purchase, gift, bequest, devise, lease or otherwise, real and personal property in Moscow, Idaho as situated and of such character and amount as shall serve the purposes of this Corporation as a Fraternity House and home for its members, and to hold title thereto absolutely, in fee for years exclusively for the use of said Corporation and its members in carrying out its social and benevolent activities.
- 2. To build, maintain and operate a suitable home in the City of Moscow, Idaho and to fully equip the same for the use of its members in carrying out the objects, aims and purposes aforesaid. Said Corporation shall also have the power to own, hold, convey, lease or otherwise dispose of any such property in furtherance of the aims and purposes of its organization.
- 3. To incur such indebtedness as shall be necessary for the acquisition of such property real and personal and for the building and maintenance of such home and fraternity house for the purposes aforesaid.
- 4. To make, execute, issue and negotiate such contracts, notes, bonds, and other evidences of indebtedness as shall be necessary, convenient or proper for the purposes of securing funds to enable it to build or buy necessary property real and personal for the carrying out of its aims, objects and purposes, and to secure the payment thereof by mortgage, pledge, trust deed, or other security upon any or all its property, real and personal. To do any and all lawful things essential thereto, and to enter into, execute and fully carry out any and all contracts necessary, convenient, expedient or proper to fully effectuate the purposes of this organization.

#### THIRD

Under no circumstances shall this corporation engage in any gainful business for the benefit or profit of its members or officers, or declare or distribute carnings, profits or dividends to any of its members or officers under any guise or pretext whatsoever. All funds and property of this Corporation shall be held and devoted solely and exclusively for the following purposes:

- 1. The maintenance, up-keep and necessary expenses of the property held by it.
- 2. The payment of its indebtedness both principal and interest at the time the same shall fall due, and the payment of all its contracted obligations of every kind and nature.
- 3. All income over and above the sums required for the purposes aforesaid shall be devoted by the Corporation solely to the carrying out of the social and benevolent purposes for which it is organized.

#### ' FOURTH

The principal office and place of business of this Corporation shall be the City of Moscow, Latah County, Idaho.

### **FIFTH**

The time for which this Corporation is to exist is fifty years.

#### STXTH

The number of directors of this Corporation shall be five.

#### SEVENTH

Prior to the execution of these Articles of Incorporation, to wit the 2nd day of September, 1949, Epsilon Gamma Zeta of Lambda Chi Alpha Fraternity, the voluntary benevolent social organization first herein mentioned in contemplation of its incorporation, held an election for directors in the City of Moscow, Latah County, Idaho; pursuant to notice as provided by law, which notice designated the time and place of holding said election and the purposes for which the same was to be held.

Said notice was given for two full weeks prior to the date of said election by publication thereof in The Daily Idahonian, a public newspaper printed and published in the City of Moscow, County of Latah, State of Idaho, in at least 12 issues of said public newspaper, the first publication of said notice being on the 3rd day of August, 1949 and the last publication thereof being on the 17th day of August, 1949. As a further notice of said meeting, a like notice was posted for the same period of time in a conspicuous place on the building in which said election was held to wit 207 West First Street, Moscow, Idaho.

#### EIGHTH

At the time and place aforesaid, the same being the time and place fixed in said notice for the election of directors and for adopting articles of Incorporation, a meeting of the members of said Epsilon Camme Zeta of Lambda Chi Alpha Fraternity was had and held pursuant to said notice, at which a majority constituting a quorum of all members of said association were present, and all members so present voted at such meeting on all matters herein mentioned.

At said meeting these Articles of Incorporation were adopted and the following named persons were lawfully and regularly elected directors, each having been chosen by the majority ballot of the members of said association present at said meeting:
