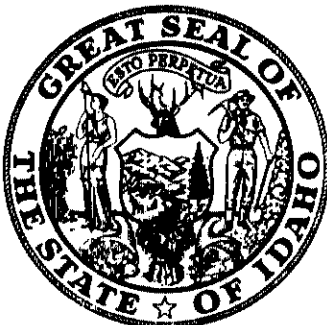

The undersigned, desiring to form a professional corporation in accordance with Idaho Code §30-1304 for the purpose of law, do hereby adopt the following Articles of Incorporation.

ARTICLE I.

NAME

The name of the corporation shall be WIEBE & FOUSER, P.A.

ARTICLE II.

PURPOSES

The purposes for which the corporation is organized are as follows:

(1) Primarily to engage in the specific business of the practice of law as a law corporation;

(2) To engage generally in the business of a law corporation as the same is now or hereafter defined by statute, rule and regulation, and in connection therewith to own property, to enter into contracts, and to transact any lawful business related thereto;

(3) To engage in such other business as may be authorized or permitted by Idaho Code §30-1307.

ARTICLE III.

PRINCIPAL OFFICE

The place in the State of Idaho where the corporation's principal office is to be located is 703 2nd Street, City of Nampa, County of Canyon.

ARTICLE IV.

DIRECTORS

The number of directors of the corporation shall be two (2), which number may be increased or decreased pursuant to the laws of the corporation, but shall never be less than two (2).
