ARTICLES OF INCORPORATION
OF
ASSOCIATED SHIPPERS OF IDAHO, INC.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, all of whom are citizens of the United States and of the State of Idaho, do hereby associate ourselves together to form a non-profit cooperative association under and pursuant to Chapter 10, Title 30, Idaho Code, and we do hereby certify as follows:

I

The name of this association is ASSOCIATED SHIPPERS OF IDAHO, INC.

II

The purposes and objectives of the Associated Shippers of Idaho, Inc. are, without pecuniary profit, to facilitate and make possible for the members of the Association, to consolidate and distribute freight for themselves and for the members thereof, on a non-profit basis, and for the purpose of securing benefits of carload, truckload or other volume rates.

To do all acts permitted by said Chapter 10 of Title 30, Idaho Code, as it now exists or as it may be hereafter amended, and all such other acts as are necessary and expedient to accomplish its stated purposes.

III

The Association shall have succession by its corporate name perpetually.

IV

The location and post office address of its registered office in the State of Idaho shall be in Ada County, Idaho.
