I.

II.

Said corporation is formed for the purpose of carrying on and conducting the business of buying, selling and dealing in General Merchancise, Farm Products, and in fact any and all kinds of business usually and generally carried on in a General Store; also to buy, seell and deal in real estate and mining claims, in the States of Montana and Idaho.
