ARTICLES OF AMENDMENT  
OF THE  
ARTICLES OF INCORPORATION  
OF THE  
TREASURE VALLEY AUXILIARY FOR THE NAMPA  
STATE SCHOOL, INC.

We the undersigned, the President and Secretary, respectively of the Treasure Valley Auxiliary for the Nampa State School, Inc., an Idaho corporation, hereby certify that at a regular meeting of the members of this corporation, duly called and held on the 21st day of February, 1970, the following resolutions were adopted by the vote of more than a ~~two~~-thirds majority of the members of this corporation present at the regular meeting, the resolutions being as follows:

FIRST, BE IT RESOLVED That Article I be, and it hereby is, amended in its entirety to read as follows:

The name of this corporation shall be the IDAHO STATE SCHOOL AND HOSPITAL AUXILIARY INC.

SECOND, BE IT RESOLVED That Article III, paragraphs (a) and (b), are hereby amended in their entirety to read as follows:

(a) Specifically and primarily to promote a better understanding of the aims and objectives of the Idaho State School and Hospital among the citizens of the Treasure Valley of the State of Idaho.

(b) To interpret the aims and objectives of the Idaho State School and Hospital to the members of this Corporation and the citizens of the Treasure Valley and of the State of Idaho, by disseminating among them information concerning subjects of general interest

THIRD, BE IT RESOLVED THAT Article VIII be, and it hereby is amended in its entirety to read as follows:

That, in the event of the dissolution of said Corporation, if any money, funds or property remain as an asset of said Corporation, the same shall be transferred to the Idaho State School and Hospital, a State Institution for the care of the mentally retarded.

FOURTH, RESOLVED FURTHER That the President and Secretary of this Corporation be and they hereby are, authorized and directed to make, execute and acknowledge a certificate of this corporation, embracing the foregoing resolutions, and to cause such certificate to be filed and recorded in the manner required by law, that is, in the office of the Secretary of State and the County Recorder of Canyon County
