ARTICLES OF INCORPORATION

OF

KIMBERLY BEAUX MINISTRIES, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Nonprofit Corporation Act, adopt the following Articles of Incorporation for such Nonprofit Corporation:

ARTICLE I

The name of the corporation is Kimberly Beaux Ministries, Inc.

ARTICLE II

This Corporation is a Nonprofit Corporation.
