ARTICLES OF INCORPORATION

OF

SACKETT'S RESEARCH WRITING, INC.

The undersigned, acting as the incorporator of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the Corporation is SACKETT'S RESEARCH WRITING, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose for which the Corporation is organized is to research and write grant applications together with all related activities and the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the Corporation shall have authority to issue is 100,000 shares, with a par value of \$10.00 per share.

FIFTH: There are no provisions denying pre-emptive rights.

SIXTH: The internal affairs of the Corporation shall be governed by a duly adopted code of Bylaws which shall be consistent with these Articles of Incorporation and the laws of the State of Idaho.

SEVENTH: The address of the initial registered office of the Corporation is 230 5th Street, St. Maries, Idaho, County of Benewah, State of Idaho, and the name of the registered agent at such address is Shelly K. Sackett.
